NSCAD University invites applications for a Tier 1 Canada Research Chair in Indigenous Art and Community Engagement or Transaltantic Black Diasporic Art and Community Engagement.

NSCAD University is in Mi'kma'ki, on the ancestral and unceded territory of the Mi'kmaq Nation. NSCAD University has committed to reconciliation and to establishing respectful ongoing relationships with Indigenous peoples.

NSCAD University is in Halifax, Nova Scotia, a city and province with a long history of settlement by Black Nova Scotians, coupled with a long history of displacement and disenfranchisement. NSCAD University has committed to reconciliation and to establishing respectful ongoing relationships with the Black communities of Nova Scotia.

We seek an innovative world-class researcher whose accomplishments have made a major impact in the field of either Indigenous Art and Community Engagement or Transaltantic Black Diasporic Art and Community Engagement. We encourage applications from outstanding, innovative researchers whose work engages with communities and establishes new arts-based research and methodologies and who have demonstrated research commitment to Indigenous and or Black Diasporic knowledges and methodologies grounded in equity, decolonization, and community engagement.

The candidate will hold knowledge and expertise in one or several of the following research areas in relation to Indigenous art (analysis, research, and/or making): relationships to land and knowledge transmission and cultural production; resistance, resilience and resurgence; nationhood, sovereignty and Indigenous relationships to land and cultural production; curatorial practice and museum representation; performance and or visual culture pedagogies; aesthetics; community consultation and activation; community collaboration; treaty relationships.

The candidate will hold knowledge and expertise in one or several of the following research areas in relation to Transatlantic Black Diasporic art (analysis, research, and/or making): visual and material culture and/or art practice; resistance and resilience; activism and critiques of anti-blackness; transnational Black Studies, transatlantic slave histories; historic and/or contemporary Black lived experiences and histories; anti-racist, anti-oppression, Critical Race Studies and/ or black feminism; curatorial practice and museum representation; performance and or visual culture pedagogies; aesthetics; community consultation and activation; community collaboration and engagement.

Tier 1 chair-holders are outstanding researchers acknowledged by their peers as world leaders in their fields. In addition to the Canada Research Chair strengthening the core programming of NSCAD, this CRC appointee will also contribute to developing productive ethical, meaningful dialogue with local, national, and international communities and will contribute to NSCAD's commitment to outreach and community engagement based on local treaty principles of respect, reciprocity and responsibility.

This Canada Research Chair Tier 1 is broadly interdisciplinary, and may engage a wide range of temporal and geographic contexts.

We seek an accomplished colleague who will join us in this journey of respectful engagement in developing research directly relevant to and in relationship with Indigenous and/or Black communities, and in leading the university in exciting new directions in relation to arts scholarship and community engagement.

The Chair will, through an outstanding, ongoing program of research and graduate training, contribute to *NSCAD's Academic Plan: Towards 2020*.

## Requirements

The successful candidate will:

- Be a world-class researcher in the field
- Have an active, original, innovative program of high quality, internationally recognized research and a vision for its future directions
- Have research that is responsive to and respectful of the needs of communities and students
- Contribute positively to the respectful and inclusive culture at NSCAD University
- Demonstrate excellence in teaching and graduate supervision
- Have earned a PhD in a relevant discipline

Consistent with Tier 1 CRC criteria, the selection committee will evaluate candidates based on: 1) their international recognition as leaders in their fields; 2) an original, innovative proposed research program of the highest quality; 3) superior record of attracting and supervising graduate students and mentoring scholars; and 4) their track record related to increasing diversity in their previous institutional environment, and in curriculum.

### Additional information

Faculty and Librarians at the NSCAD are governed by the provisions of the Collective Agreement (FUNSCAD Unit 1). The successful applicant will be nominated by NSCAD University for a Tier 1 Canada Research Chair and, upon approval of the Chair by the CRC Secretariat, will then be offered an appointment at the rank of Associate or Full Professor at the University (rank will be determined as per the evaluation policy). The anticipated start date for this position is January 1, 2020.
