



The Division of Art History & Contemporary Culture, NSCAD University invites applications for a Tenure Track/Tenured Position at the Assistant/Associate Professor rank in Art Education.

NSCAD University is in Mi'kma'ki, on the ancestral and unceded territory of the Mi'kmaq Nation. NSCAD University has committed to reconciliation and to establishing respectful ongoing relationships with Indigenous peoples.

We seek a candidate whose accomplishments have made (Associate) or have the potential to make (Assistant) a major impact in the field of Art Education.

We encourage applications from innovative and effective scholars who work in arts-based research focuses on methodologies and connecting theory and practice, and who also have a demonstrated commitment to equity, inclusion, justice, decolonization, human development, and well-being in their practice.

The candidate will hold knowledge and expertise at least one of the following research areas in Art or Visual Culture Education:

- Curriculum Design & Development
- Studio Art Pedagogy
- Student Teaching & Service Education

Research emphasis on community engagement, resilience, strength-based frameworks, and place-based perspectives is considered particularly relevant. Lived experiences of making and working with marginalized and racialized groups is an asset. The ideal candidate will enhance cross-university research and pedagogical collaboration by partnering with other departments, programs, and faculties.

The successful candidate will teach in the newly established research-based Master of Arts in Art Education program, as well as undergraduate offerings for pre-and-in-service teachers (BEd visual arts training and Visual Arts Certificate Program for Teachers) and courses in Contemporary Culture that are open to the full NSCAD community. The candidate will be invited to participate in graduate student mentorship and supervision.

We seek a colleague who will join us in this journey of respectful engagement in developing research directly relevant to and in relationship with communities, and in leading the university in exciting new directions in relation to Art Education practice and scholarship. Criteria for the position:

- PhD in Art Education or closely related discipline before the time of appointment
- Potential as a leader (Assistant) or demonstrated leadership (Associate) in their fields
- Active, original, innovative program of high-quality research and a vision for its future directions

- Demonstrated experience and capacity for scholarship in Art Education pedagogy, including peer-reviewed publications and conference presentations
- Evidence of an ongoing art practice (studio or community-based)
- Successful post-secondary teaching
- Successful teaching with children, youth or other age-based cohorts in institutional or community contexts
- Commitment to integrate appropriate technologies, resources, and materials into classroom contexts and across studio disciplines
- Potential for establishing and sustaining national and international collaborations
- Potential for attracting and mentoring graduate students

Additional information about Faculty and Librarians at NSCAD are governed by the provisions of the Collective Agreement (FUNSCAD Unit 1). The anticipated start date for this position is July 1, 2020.

Application materials should include:

- A cover letter providing an overview of the candidate's qualifications and how they fulfill the above listed criteria
- A research statement (1-2 pages)
- A curriculum vitae
- A writing sample of a single-authored publication
- A teaching dossier that documents the applicant's experience in and approach to training diverse students, and teaching effectiveness, to include examples of syllabi and student work, teaching philosophy, examples of collaborative outputs such as work with schools or community members through approaches social practice, participatory arts, cultural development, or similar
- Evidence of an ongoing art practice (studio or community-based) demonstrating connection between making and scholarship
- Contact information for at least three referees

Candidates are encouraged to submit application materials as a single PDF document.
