All candidates must possess the qualifications, experience and commitment required to govern an institution of the scope, complexity, and caliber of NSCAD University, and should reflect the diversity of the communities served by the University. NSCAD University seeks to foster a Board composed of

members who have a passion for post-secondary education especially in the areas of art, craft, and design, who have vision and are highly effective communicators, able to consider multiple and divergent perspectives in decision making and are committed to good governance.

Governors are required to engage at a strategic level and should be willing to serve in a leadership role within the Board or Standing Committees if asked.

If you can commit the necessary time and energy to the Board, are willing to participate in the life of NSCAD University as an active ambassador, and advocate and have a desire to deepen your association with the University, we welcome your application.

Board Membership involves a time commitment of approximately 1-2 weekdays per month for meeting attendance at Board and Standing Committee meetings, plus 6-10 hours per month for review of meeting materials. In addition, Board members are encouraged to attend University events, as much as possible, to familiarize themselves with University life and activities.

Board members serve as volunteers and do not receive remuneration for this activity.

NSCAD Board structure

Framework:

The Nova Scotia College of Art & Design (NSCAD) University is a public institution governed in accordance with the University Act of Nova Scotia.

The Board consists of Governors in Council (appointed by the Province of Nova Scotia), Governors at Large, internally elected students and faculty members, and representatives from the Alumni Association. The President of the University is an ex-officio voting member. The Board meets at least six (6) times each year, plus once for the AGM. Further information on the Board, its committees and meeting dates can be found <u>here</u>.

It operates with a bicameral governance system, with two senior governance bodies: a duly constituted Board of Governors and a Senate, both of which include representation from faculty, staff, administration, and students.

Role and Responsibilities:

The Board of Governors shapes NSCAD's strategic direction while providing governance oversight of the University. The Board of Governors has full responsibility for ensuring effective management, administration and control of property, financial operations, and affairs of the University, except for

matters specifically mandated to the Senate. The Board also deliberates on decisions related to strategic planning, human resources, and the hiring, oversight, and appointment/reappointment of the President.

Standing Committees:

Following a typical Board structure, the Board delegates some of its deliberations to four standing committees.

The <u>Advancement Committee</u> supports the NSCAD Board of Governors' stewardship responsibilities relating to strategic planning and advancement, and provides active leadership in support of the Advancement Office's efforts in such areas as fundraising and friend-raising.

The <u>Audit & Risk Oversight Committee</u> supports the NSCAD Board of Governors in the fulfillment of its stewardship responsibilities in the following areas: financial oversight, risk oversight, and monitoring the integrity of internal controls and management information systems.

The **Financial & Physical Resources Committee** supports the NSCAD Board of Governors in the fulfillment of its stewardship responsibilities in the following areas: oversight of NSCAD's financial planning and policy framework including multi-year financial plans and annual budgets; monitoring NSCAD's ongoing financial performance and needs; oversight of NSCAD's investments; and oversight of NSCAD's short and long-term plans for its physical facilities.

The <u>Governance & Human Resources Committee</u> supports the NSCAD Board of Governors in its efforts to continuously improve the effectiveness and efficiency of its governance and its oversight of NSCAD's management of human resources.
