## Planned Giving — The Anna Leonowens Legacy Society

The Anna Leonowens Legacy Society recognizes and honours friends and members of the NSCAD University community who have thoughtfully provided for its long-term sustainability. Members of the Society have remembered NSCAD University in their wills and are invited to an annual private event (in person or remote) and are recognized in our annual donor report.

By including NSCAD in your estate plans, you are ensuring our faculty, students and alumni are able to identify, define and approach the complexities of our world, challenge conventional thinking, and create value and economic impact through art, media, craft, and design. If supporting the innovators, thinkers and makers so they can help us see our present and re-imagine our future is important to you, a legacy gift to NSCAD will help you realize your philanthropic goals.

To become a member of the Anna Leonowens Legacy Society please notify us that your will, trust or life income arrangement provides for NSCAD University.

There are many ways to make a planned gift to NSCAD University, all of which can be tailored to meet your specific financial and estate planning needs. A planned gift can help you achieve your tax and financial objectives, as well as your philanthropic goals, and can help you make a much more impactful gift than would be otherwise possible. Planned giving provides opportunities for you to choose the best assets with which to make a gift. Planned giving expands these charitable gift vehicles that may be integrated into your personal financial and estate planning. Since no two planned gifts are exactly alike, assets that may be used for a planned gift include, but are not limited to:

- Bequests
- Life Insurance
- Charitable Gift Annuities
- Charitable Remainder Trust
- Gift of Residual Interest
- RRIFs and RRSPs

In addition to discussing how to make your planned gift, NSCAD will work with you to determine how the funds will be utilized. NSCAD is committed to growing its endowment, which provides annual income for many important aspects of university life that are not supported through its regular operating budget. Many donors choose to let the university decide and leave an unspecified gift, citing that a gift is for general purposes. However, you also may specify the purpose if you wish. Your planned gift can help provide funds for:

- Establishing awards, bursaries or scholarships
- Supporting facilities or departments
- Providing faculty development opportunities
- Funding new equipment or other campus improvements
- Supporting programming enhancements such as lecture series, visiting artists, residency programs, and more.

We can work with you and your professional legal and financial advisors to create a personalized planned gift. This will help NSCAD University continue its legacy of excellent art, craft, media, and design education while also providing you and your family benefits. We also encourage you to discuss your gift intentions, in confidence, with us to assist you with wording related to your gift and ensure that the university is able to fulfill your intentions and recognition request.

## **Bequests**

A bequest is a simple provision in your will directing a specific dollar value or percentage of your estate to NSCAD University. You may also designate stocks and securities, real estate or other personal property. You can direct your gift to a specific priority of interest (scholarships, bursaries, a particular department) or leave it to NSCAD University's area of greatest need. A charitable bequest to NSCAD may provide a significant tax advantage for your estate. Your executor can claim charitable bequests equal to 100 per cent of the income on your final two tax returns.

## **Life Insurance**

You can name NSCAD University as the beneficiary of a new or existing policy, thus building a significant gift for the future by paying relatively low premiums now. Once NSCAD University is named as beneficiary of your policy, you will receive a tax receipt for premiums paid. Another option is to purchase or transfer ownership of a policy where NSCAD University is the policy owner and you pay the premiums. With this option, you also receive a tax receipt for premiums paid.

## **Charitable Gift Annuities**

Annuities provide regular payments (annual, semi-annual or quarterly) to you in return for a charitable gift of cash or securities. Charitable gift annuities provide immediate tax relief, a guaranteed income for you and a charitable contribution to NSCAD University at the same time. Regular payment amounts to you are fixed from the outset and are unaffected by stock markets or interest rate fluctuations.

## **Charitable Remainder Trust**

A charitable remainder trust is an irrevocable gift to NSCAD University that provides you with immediate tax relief on the net present value, based on an actuarial calculation. Your tax credit, if over 75 per cent of your net income in the year it is given, can be carried forward for up to five years. In the meantime, you receive a lifetime income unaffected by stock markets or interest rate fluctuations and the gift's value is not subject to probate.

## **Gift of Residual Interest**

This is a way of making an immediate gift of personal property, such as real estate, and receive a charitable receipt now while retaining it for your own personal use during your lifetime. Residual interest gifts should, whenever possible, be discussed with a professional planned giving advisor before you proceed.

## **RRIFs and RRSPs**

You can name NSCAD University as a beneficiary of your registered retirement plan and your estate will receive a tax receipt for the fund's final value, thus allowing your estate to avoid tax on the fund's full value in the year of death (unless remaining funds in your RRIF or RRSP can be rolled over to a surviving spouse or dependent child). Such gifts are not subject to probate.

## Sample Will Clauses for Bequests

This information has been prepared for the use of lawyers, estate planning or other financial professionals when acting for clients who wish to make gifts by will to NSCAD University. The suggested wording is provided in the form of examples and can be amended to suit an individual's circumstances. It is strongly recommended that donors seek legal advice when incorporating a charitable bequest into their estate plans. This will ensure the clause chosen is properly placed in overall structure of the will, thus ensuring that the gift will be valid.

The following language is suggested for use in making an unrestricted bequest:

*I give (the sum of \_\_\_\_\_ dollars) OR (all or \_\_\_\_\_ per cent of the residuary of my estate) to NSCAD University, 5163 Duke Street, Halifax, NS B3J3J6, Charitable Registration Number 107788192RR0001.*

The following language is suggested for use in making a restricted bequest:

*I give (the sum of \_\_\_\_\_ dollars) OR (all or \_\_\_\_\_ per cent of the residuary of my estate) to NSCAD University, 5163 Duke Street, Halifax, NS B3J3J6, Charitable Registration Number 107788192RR0001, for: (state purpose: e.g., general purposes, a scholarship fund, or a particular department. Please contact NSCAD University before finalizing your will to discuss restriction options.)*

The following language is suggested for use in establishing an endowment for a specific purpose:

*I give (the sum of \_\_\_\_\_ dollars) OR (all or \_\_\_\_\_ per cent of the residuary of my estate) NSCAD University, 5163 Duke Street, Halifax, NS B3J3J6, Charitable Registration Number 107788192RR0001, to create an endowed fund, the earnings from which, subject to the university's Annual and Endowment Fund Management Policy, are to be used for the following purpose: (state purpose: e.g. general purposes, a scholarship fund, or a particular department. Please contact NSCAD University before finalizing your will to discuss restriction options.)*

It is recommended that a "power to vary purpose" clause be included in your will, directing the university in the event that the original terms of the agreement cannot be fulfilled.

*Academic priorities at the university may shift over time, and it may become impossible, inadvisable or impracticable to apply the bequest for the purpose set out above. If the university is of the opinion that a revised purpose is appropriate, the university shall exercise its discretion, in consultation with the estate where possible, and use the bequest to the best advantage of the university for other purposes consistent with the spirit and intent of the bequest. The identity of any named funds will be retained and will always bear the name indicated by the estate.*
